Please note: All vendors, including winter/summer-only vendors, must be current members of Bennington Farmers' Market. Annual membership dues of \$25 run November through October. All members receive a vote at the Annual Membership Meeting in the Fall.

**Stall Fees for a 12-foot space.** You can pay as you go for \$15 per market day or pay in advance for the full season (27 markets). Paying in advance entitles you to a 10 percent discount. Full season payments are due by the first summer market.
