(One membership = one vote. Membership is required of all vendors, including Winter season-only vendors.)

Saturday Stall Fees for a 12 foot space. You can pay for a full season (26 weeks) for \$340 which saves almost \$2.00 per market day or pay as you go for \$15 per market day. Full season payments are due by the first market.
